



**NOMINATION PETITION FORM FOR THE ELECTION OF THE CUSTOMERS REPRESENTATIVE
BEFORE THE GOVERNING BOARD OF THE PUERTO RICO ELECTRIC POWER AUTHORITY**

Act 83 of May 2, 1941, as amended by Act No. 37 of June 26, 2017, and in accordance with Regulation 9008 promulgated by the Department of Consumer Affairs [DACO by its Spanish acronym] on January 23, 2018, establishes that the Board of Directors of the Puerto Rico Electric Power Authority ("PREPA") must appoint one (1) representative of the customers' interests before the Governing Board. This representative must be elected by consumers through a referendum supervised by DACO. The position of PREPA customer representative is currently vacant. The following information must be provided to be eligible for nomination:

CANDIDATES MUST MEET THE FOLLOWING REQUIREMENTS:

1. To be of legal age.
2. To have an educational and professional background of not less than ten (10) years' experience in their professional field.
3. The educational and professional background requirements must include, at least, the field of electrical engineering, business administration or economy and finances.
4. To have expertise in energy affairs.
5. To not be a public employee, except a professor in the University of Puerto Rico System.
6. To not be an employee, a retired employee or have a substantial economic interest, either direct or indirect, in any private company with which PREPA executes contracts or performs transactions of any nature, including borrowing money or supplying raw materials.
7. In the three (3) years preceding the position, to not have had a commercial interest in, or relationship with, any private company with which PREPA executes contracts or performs transactions of any nature.
8. To not be an employee, member, advisor or contractor of PREPA worker unions.
9. To accept the same rights and responsibilities as the other members sitting on the Governing Board.
10. To have met all other requirements applicable to persons who wish to work as public servants.
11. To be a bona fide customer of the electric power service provided by PREPA.
12. To provide the following certifications:
 - a. Certificate of Filing Income Tax Returns for the last five (5) tax years.
 - b. Certificate of No Debt issued by the Treasury Department.
 - c. Certificate of No Debt from the Child Support Administration (ASUME by its Spanish acronym).
 - d. Certificate of No Debt from the Municipal Revenue Collection Center (CRIM by its Spanish acronym).
 - e. Certificate of No Criminal Record from the Puerto Rico Police Department.
 - f. Certificate of No Debt from PREPA.
13. To have the attitude, aptitude and availability to perform the duties of the position.
14. To provide any other document required by law.
15. To meet any other applicable, legal or regulatory requirements.
16. To fill out the Nomination Petition Form.

SUBMITTAL:

When sending the Nomination Petition Form, you must include the endorsement forms signed by not less than thirty (30) residential customers, with their full names, addresses and PREPA account numbers, ten (10) commercial customers and ten (10) industrial customers with the account number, name, title and signature of an authorized officer of such customer endorsing the petitioner's nomination. A letter drafted on letterhead paper and signed by one (1) officer of every commercial or industrial customer must also be included, certifying that the customer endorses that candidate. The seven (7) nominees who present the most endorsements and meet the requirements laid down in Act 37 of June 26, 2017 and Regulation 9008, shall be elected as candidates.

Every nominee shall submit no later than **January 30, 2019**, the Nomination Petition Form, the required certifications as established in paragraph twelve (12) of said form and the fifty (50) or more endorsements in original electronically to **eleccionesaee@daco.pr.gov** or by regular mail to the following mailing address: **PO Box 40745, Minillas Station, Santurce, PR 00940-0745**. Those who choose to send the form and endorsements by email, must retain the original endorsements in order to provide them to the Customer Representative Nomination Committee, upon the Committee's request. A 2 x 2 photograph must also be provided along with all the documentary requirements. Incomplete applications will not be accepted.
